Dear Mr. Findley:

This letter is regarding Mercury Broadband's obligations under the Federal Communications Commission's (FCC) Rural Digital Opportunity Fund (RDOF) program in Bridgewater Township, Washtenaw County, Michigan.

Bridgewater Township is the only remaining community in Washtenaw County where RDOF-funded broadband deployment remains largely incomplete. Mercury told Washtenaw County residents that they would be fully serviced by the end of 2024. However, as of December 2025, only approximately 32 percent of homes in Bridgewater Township have received connectivity. Local officials further report that there has been no meaningful construction activity in the township throughout 2025.

This lack of progress is especially concerning given Mercury's prior RDOF defaults in Michigan and the company's continued responsibility for certain remaining locations, including Bridgewater Township. Despite Mercury's ongoing receipt of federal support under the RDOF program, Washtenaw County officials have indicated that they have been unable to obtain timely updates from Mercury regarding construction plans, deployment timelines, or compliance status for Bridgewater Township.

To better understand Mercury's plans and to ensure that residents of Bridgewater Township receive the broadband service promised under the RDOF program, I request the following information:


- A status update on broadband deployment in Bridgewater Township, including an explanation for why no construction activity has occurred in the township during 2025;

- The contact information of a Mercury representative whom Washtenaw County, local officials, and I may contact to receive regular updates regarding deployment progress;
- Mercury's anticipated timeline for completing broadband deployment in Bridgewater Township; and,
- A meeting to discuss Mercury's deployment plans, outstanding RDOF obligations, and next steps for completing service in Bridgewater Township.

Clear and consistent communication with local stakeholders is essential to restoring confidence that Mercury will meet its remaining RDOF obligations. I urge the company to engage directly with Washtenaw County officials and provide transparency regarding its plans for completing this long-delayed deployment.

Thank you for your attention to this matter. We need to ensure that Bridgewater Township residents are not left behind. I look forward to your response.
